## Amendment No.1 To the Services Agreement dated 10<sup>th</sup> June, 2020

This Amendment No.1 to the Services Agreement dated 10<sup>th</sup> June, 2020 (hereinafter "Amendment") is made on 5<sup>th</sup> day September, 2020 and effective from 1<sup>st</sup> August, 2020 ("Effective Date"), made by and between

MERITTRAC SERVICES PRIVATE LIMITED having its registered office at Manipal Towers, # 14, Airport Road, Bangalore, 560008, India (hereinafter referred to as "MeritTrac")

## And

MANIPAL ACADEMY OF HIGHER EDUCATION having its registered office at University Building, Madhavanagar, Manipal-576104, Karnataka (hereinafter referred to as "MAHE").

Both MeritTrac and MAHE are hereinafter referred collectively as "Parties" and individually as 'Party', as the context may require.

## WHEREAS:

- 2) For avoidance of doubt, capitalized terms unless otherwise defined herein shall bear the same meaning as ascribed to them under the Agreement.
- 3) It is hereby clarified that all the other terms and provisions of the Agreement, shall be binding and remain in full force and apply mutatis mutandis.
- 4) This Amendment represents the complete understanding between the Parties, as agreed herein under such terms and conditions as set out in the Agreement and shall be read along with Agreement and forms integral part of Agreement.
- 5) The Parties may sign and deliver this Amendment by affixing their digital signature or may be executed in two (2) counterparts, each of which shall be deemed an original, and each of which shall constitute one and the same instrument.
