Ref: Your letter dated 19th August, 1952.

I am directed to state that the Government have examined your requests very carefully and they regret that they are unable to give any financial assistance to the proposed institution at this stage in the present condition of the State's finances. They will, however, be prepared to alienate the Government vacant lands in Udipi in favour of the proposed Medical College, when specific proposals for the same are received and to permit the Government hospitals at Mangalore and Udipi being used for the clinical training of the students of the proposed college. I am also to say that the Government will not be in a position to give any further help to the Academy of General Education, and that all financial responsibility in respect of the college should rest on its sponsors and their friends.

ORDER:

In their letter (Ms) No. 3048 Health, dated 25th September 1952, the Government informed the authorities of the Kasturba Medical College, Udipi, South Kanara District, that they would be prepared to permit the Government Hospitals at Mangalore and Udipi being used for the clinical training of the students of the College. They have now considered, in consultation with the Director of Medical Services, the proposals made by the authorities of the College for the training of students at Mangalore and they pass the following orders.

2. The Kasturba Medical College will be provided with three Surgical and three Medical Units at the Wenlock Hospital, Mangalore, and one Gynaecology and Obstetrics Unit at the Lady Goschen Hospital, Mangalore. Each of the above seven units will consist of the following staff:-

(a) A Professor of the College (also designated as Director) who will also be an Honorary Medical Officer (Honorary Surgeon or Honorary Physician, as the case may be) of the Government Hospital concerned.

p.t.o.

(b) A paid Assistant Surgeon of the Madras Medical Service in the category of Clinical Tutor.

(c) An Honorary Assistant Medical Officer (Honorary Assistant Surgeon or Honorary Assistant Physician, as the case may be).

For the above purpose, the Government sanction the creation, temporarily, from 1st January 1955 upto 29th February 1956, in the first instance, of six posts of Clinical Tutors in the Wenlock Hospital, Mangalore and one post of Clinical Tutor in the Lady Goschen Hospital, Mangalore, on the usual scale of pay of Rs. 150-400 (Graduates to start on Rs. 200) and allowances. The posts will be temporary additions to category 11 of Class I of the Madras Medical Service. The Director of Medical Services is requested to take steps to fill the posts urgently. The entire expenditure involved on account of the above posts, including the leave and pensionary charges, should be recovered from the authorities of the Kasturba Medical College, Udipi, who have agreed to meet this expenditure.

3. The Government approve the suggestions of the Director of Medical Services that the present Honorary Medical officers of the Government Hospitals concerned should be employed by the College authorities on terms of mutual agreement and that the Ear, Nose and Throat, Ophthalmic, Tuberculosis etc. Departments should be placed in charge of Honorary Assistant Surgeons who will do the teaching work on conditions mutually accepted. They also approve his proposals regarding allocation of beds, admission and operation days.

4. The attention of the Director of Medical Services is invited to letters No. P.O.1543/54-55, dated 8th October 1954 and No. 2212/54-55, dated 22nd November 1954, from the Registrar of the Kasturba Medical College, addressed to him, (copy sent to Government also), and he is requested to submit urgently proposals for the appointment, as Honorary Medical Officers and Honorary Assistant Medical Officers in the Government Hospitals concerned, of the teaching staff of the College. In this connection, the Government direct that the provision of the above facilities shall be subject to the following three specific conditions:-

(a) The authorities of the College must safeguard the interests of the Honorary Medical Officers who are at present working in the Wenlock and the Lady Goschen Hospitals, Mangalore and their successors who will be appointed by Government in accordance with the existing rules, by suitably providing for them.

(b) In the future selection of Medical Officers for appointment to teaching posts in the College, a representative of the Government, preferably the Director of Medical Services, must be on the Selection Committee



in view of the fact that the Medical Officers appointed as Clinical Teachers on the staff of the College, will have also to be appointed as Honorary Medical Officers in the Government Medical Institutions at Mangalore.

(c) In the administration of the two hospitals, the District Medical Officer will be advised by an Advisory Committee. The Committee will consist of the Directors of the Clinical departments in the hospital concerned and the District Medical Officer will be the President of the Committee and cases of major difference of opinion may be referred to the Director of Medical Services for his decision.

5. With reference to the further arrangements proposed in the letter dated 8th June 1954 of the Registrar, Kasturba Medical College, cited above, the Government direct as follows:-

(1) Appointment of District Medical Officer, with specialist qualification:

The Government consider that it will not be possible for the District Medical Officer, South Kanara, to teach one of the subjects in the Kasturba Medical College. They also regret their inability to comply with the request of the authorities of the College that they may be permitted to avail of the services of the District Medical Officer as a part-time Professor or Lecturer, if he happens to be a specialist in any subject.

(2) Appointment of a Police Surgeon and an Officer with M.D. (Pathology) qualification as Assistant District Medical Officer, South Kanara.

The Government regret that it is not possible to appoint an Associate Professor of the College as Police Surgeon at Mangalore and also to post Dr. B.M. Venugopal Shetty, Assistant Surgeon, as Assistant District Medical Officer, South Kanara, or to lend his services to the College on foreign service terms.

(3) Lending of the services of Dr. M. Viswanatha Bhat, Assistant Professor.

The Government have no objection to the services of Dr. M. Viswanatha Bhat, Assistant Professor of Surgery, Madras Medical College, Madras, being lent to the Kasturba Medical College on foreign service terms. The Director of Medical Services is requested to ascertain and report the terms on which he will be employed in the Kasturba Medical College, so that formal orders in this behalf may be issued at an early date.

(4) Appointment of a Radiologist:

The question of appointing an officer with N.M.R. qualification to the Radiology Department of the

Wenlock Hospital, Mangalore, will be taken up for consideration when the department is suitably equipped as for a teaching medical institution.

(5) Appointment of an Anaesthetist and Venereologist:

The Government regret that it is not possible to spare the services of an Anaesthetist and a Venereologist from the Madras Medical Service to the College. They consider that it would be more appropriate for the College authorities to create a post of Lecturer in Anaesthesia and a post of Lecturer in Venereal Diseases on the College staff to be attached in an honorary capacity to the Hospital and that they can also advertise and recruit suitable candidates to the posts.

(6) Medico-legal work:

The Government permit the Professor of Pathology of the Kasturba Medical College to conduct post-mortems only on the bodies of unclaimed patients and destitutes at the Wenlock Hospital, Mangalore. They also agree to post an Assistant Surgeon of the Madras Medical Service, to work under the Professor of Forensic Medicine of the College. For this purpose, they sanction the creation, temporarily, from 1st January 1955 upto 29th February 1956, in the first instance, of one post of Non-clinical Tutor in the Wenlock Hospital, Mangalore, on the usual scale of pay of Rs. 150-400 (Graduates to start on Rs. 200) and allowances. The post will be a temporary addition to category 8 of Class I of the Madras Medical Service. The Director of Medical Services is requested to take steps to fill the above post also urgently. The entire expenditure involved on account of the above post also, including the leave and pensionary charges, should be recovered from the authorities of the College who have agreed to the recovery being effected. The Government further direct that the post-mortems connected with medico-legal cases should be performed by the Government medical officer only.

(7) Improvements to the Radiology Department of the Wenlock Hospital, Mangalore.

Separate orders will be issue regarding this item.

(8) The Government do not accept the proposal of the College authorities to pay special emoluments to the officers of the Madras Medical Service, doing teaching work in the College. They will however be eligible for teaching special pay at the rate of Rs. 30/- per mensem as in a Government Medical College.

6. The Director of Medical Services is requested to furnish necessary particulars to the Accountant-General with reference to paras 2 and 5(6) above so as to enable the latter to raise the necessary debits against the authorities of the Kasturba Medical College, Udipi, from time to time.
