Overview and purpose:

To promote and fund research projects between Manipal group of universities. Nature & Duration of Support:

- The proposed research in response to Call for Proposals should be clearly defined. The objectives should be smart, measurable, achievable, relevant and time bound and in alignment with MRB priorities.
- Multidisciplinary projects having topics of research of global and national importance or priority issues or topics aligned to SDG, however not limited to, would be preferred.
- The joint research should have the potential for publications in high-end journals and translatable patents in addition to scaling to secondary extramural grant.
- Seed money up to Rs. 10.0 Lakhs (Ten lakh) will be provided under MRB grant.
- Maximum duration of project will be two years. An additional period of up to six months (with no additional costs) can be considered by the monitoring committee.
- The research grant will cover equipment (only if justified), consumables, and contingency. Travel of PI and Co-PI once in year to be utilized by mobility grant. Manpower will not be covered in the grant.

Mode of Application, selection, and monitoring:

- A proposal to be submitted to respective Directorate of Research (collaborating partners parent institutes) through proper channel, (through the Head of the Department and Head of the Institute), in hard copy and/or soft copy, in the prescribed format. Annexure-I (Part A & B)
- Proposal will be evaluated for feasibility & potential by a Selection Committee and result to be notified as:

Date of announcement of first call April 2, 2024

Last date of project submission to respective DOR: 15th May 2024 Announcing awardees 2 months after last date

- All subsequent filing applications received as per format with respective DoRs will be evaluated for feasibility and the decision will be made known.
- The Committee will also monitor the progress of the projects periodically.

Eligibility:

- Full time Faculty member of Manipal group of Institutions holding a PhD degree (MD/MS only in case of Medicine and Dental faculty) with a proven track record of quality research and having at least two years for retirement.
- Faculty in the post of Associate professor and below will be eligible for Principal Investigator.
- Faculty in the post of Professor will be eligible only as a co-investigator.
- Faculty on probation will be eligible only as co-investigator.
- Project should consist of collaborators from different institute of Manipal group.

- Each collaborating institute must have at least two investigators (One as PI and other as Co-PI).
- One person can only handle one project at a time. Once awarded a person cannot apply again for next two years.

Details about utilization:

- The amount to be utilized for actual cost towards research activities for consumable, field visit for collection of data (Capped at 40% of total grant), testing/diagnostics expenses.
- The amount excludes incentives, salaries, publication charges, conference/workshop registration and fellowship.
- All the bills to be finalized as per the Finance policy of the respective institutions.

Termination clause:

- If in case the lead investigator drops from the project the co-investigator in consultation with another investigator may choose to continue with the project or terminate the project, with no further financial assistance.
- Project which does not submit progress report for two consecutive cycles will be treated discontinued.
- Projects that have not utilized at least 20% of the prescribed grant during the first year will be terminated.
- Projects deviating from the projected objective will not be considered for further funding.

Withdrawal clause:

• Researchers may withdraw the project by submitting an application to respective DoR before six months of the project sanction.

Expected Outcome:

- Mandatory:
 - At least two original research papers in SCOPUS (Q1 or Q2) or JCR listed journals. (Minimum one by end of one year)
 - Submission of one major grant proposal for extramural funding agency. (by end of one year)
- Desirable:
 - Patent (s).

Format for submission of Project Proposal PART-A

1. Title of the proposed research project (up to 25 words): should be specific, concise, and yet sufficiently descriptive and informative.

2. Summary (up to 250 words): A structured summary should contain the following subheadings: Rationale/ gaps in existing knowledge, Novelty, Objectives, Methods, and Expected outcome.

Does it cover a priority area/ is it aligned to SDG? If yes, please specify.
Keywords: Six keywords separated by comma which best describe your project may be provided.

5. Abbreviations: Only standard abbreviations should be used in the text. List of abbreviations maximum of ten may be given as a list.

6. Problem Statement (up to 500 words): State the currently available information to present the problem adequately.

7. Rationale (up to 250 words): Mention how the research question addresses the critical barrier(s) in scientific knowledge, technical, Capability, and/or programmatic/clinical/lab practice and its relevance to local, national, and international context with relevant bibliography.

8. Hypothesis/ Research question (up to 100 words): Please provide details.

9. Objectives (up to 25 words/ objective): Define the objectives clearly and in measurable terms; mention as primary and secondary objectives, if necessary. Do not include more than 3-4 objectives.
