- a. Regarding Additional Surcharges and Cross Subsidy Charges, the orders issued from time to time by the Hon'ble Commission shall be applicable.
- b. Any other charges as determined by the Commission from time to time & as per MESCOM norms.

Conditions:

- a. Wheeling of energy is subject to availability if quantum of energy available for wheeling in the account of generator including the actual generation in the month of **November-2024**.
- b. The wheeled energy to be treated as FIRST CHARGE on the total consumption by the individual HT consumers and only the balance portion of the consumption is to be billed as per the applicable tariff.
- c. The consumer having outstanding arrears to KPTCL/MESCOM will not be eligible for availing wheeled units.
- d. Charges payable by the Consumers are to be levied as per prevailing tariff order.
- e. Electricity Tax shall be calculated and payable by the consumer as per MESCOM Circular No. SEE(Coml)/ EE(RA)/ AO(RA)/ 2017-18/ Cys-39/27.03.2018 & SEE(Coml)/ EE(RA)/ AO(RA)/ 2018-19/ Cys-18/ 02.08.2018. In case if any inconsistencies the prevailing electricity tax rules of the Government prevails.
- f. This official Memorandum is subject to reconciliation as per directive letter of Hon'ble KERC vide letter No. KERC/Group-Captive/CT-2/18-18(Vol-II)/1400 dated 26-01-2022.
- g. The wheeling of energy to the installation having SRTPV facility is to be in strict compliance with the Hon'ble KERC order dated: 18-07-2022.
